1. Out of gas

Issue:

- The function `includeInReward()` uses the loop to find and remove addresses from the `_excluded` list. Function will be aborted with `OUT_OF_GAS` exception if there will be a long excluded addresses list.
- The function `_getCurrentSupply()` also uses the loop for evaluating total supply. It also could be aborted with `OUT_OF_GAS` exception if there will be a long excluded addresses list.

Recommendation:













Check that the excluded array length is not too big.

Owner privileges (In the period when the owner is not renounced)



- Owner can change the tax, _developmentFee and liquidity fee.
- Owner can change the maximum transaction amount.
- Owner can change swapAndLiquifyEnabled.
- Owner can exclude from the fee.
